General Shipments tendered to KRC on a plastic shrink wrapped pallet/skid, shall be signed as one of the following:

- Shrink-wrapped skid(s)
- Shrink wrapped pallet(s)
- SWP
- SWS
- SWP
- UTC
- SWP STC

When a plastic shrink-wrapped skid is delivered to the consignee intact, with the plastic shrink wrap unbroken, KRC shall assume no liability for loss or damage, either at delivery or after delivery has been performed. Pallets are only considered to be "not intact" at time of delivery, unless a written exception indicating number of pallets and not intact.

The driver will sign only for the number of pallets, not the number of pieces. A driver's signature declaring "pieces" of the load vs pallets, is deemed ineffective that KRC received specific number of pieces.

KRC does our best to meet appointment times and requested arrival dates, occasionally unforeseen issues arise due to traffic, weather, excessive unloading times, etc. Unfortunately, we do not have much control over these issues and therefore cannot make service guarantees. Therefore, KRC Logistics will not be responsible for payment of consignee fines/claims. Product cargo claims must be presented to KRC in writing within 9 months from the date of delivery.

KRC limits claim liability to $\$ 0.50$ per pound. KRC will not accept claims for loss or damage of property, goods, or cargo less than $\$ 50.00$ total cost. Carrier will have the right to salvage any damaged product resulting in a claim.
